

## Bathroom window fall from a unit of middle floor at Abbey

On 10th March 2019, Management Office reported that a bathroom window fell from a unit of middle floor at the lightwell between unit B & C in Abbey Court and it damaged some external drainages and effected many units. Fortunately nobody was injured in this case. We suspended flush water for unit B & C to reducer further damage, incident area was fenced off and arrange contractor for checking. All of the repair cost will be bear by the anecdote unit, therefore we suggest all owners should consider purchasing a suitable home insurance for emergency needs. Besides, this case had been reported to the H.K Police Force for record.





Please note under Section 4B of the Summary Offences Ordinance, if anything is dropped or allowed to fall from any building to cause danger or injury of any person in or near a public place, the person who drops that thing or allows it to fall commits an offence and is liable to a fine of \$10,000 and imprisonment for 6 months. If the falling window causes injuries or loss of life, the victim or their family members may also claim compensation against the owner of the flat. For safety reason, please consider to appoint a qualified contractor to carry out the prescribed inspection of all windows to your apartment.
